Inter-generational Poverty in Hong Kong
Inter-generational poverty has been a long term hindrance to the development of
Hong Kong, Nearly 210,000° children under 18 live below the poverty line. The Government
introduced the CDF poverty alleviation policy (waw.cdf.gov.h.). Largeting to help youths
aged 10 to 16 from an economically-deprived background shake off poverty. It is proven by
international research as a very effective way to address inter-generational poverty.
Its 3-pronged approach includes: Targeted Financial Planning, Quality Mentorship and
Personal Development Plan (see diagram).

The CDF programme is supported by two other charities besides CDIA — "Child Development Matching Fund" (CDMF, www.cdm.Corg.ht), and "Quality Mentorship Network" (QMN, www.qmn.ht). They share similar conviction to advocate a holistic caring culture for the youths, where the Government, the business sector and the community should collaborate and invest both money and time into youth development, helping them get out of poverty.
